

Twitter Competition Terms & Conditions

1. Subject to these Terms and Conditions, all persons who respond to the specified tweet on the PGA European Tour Twitter page (the “**Tweet**”) before the stipulated closing deadline will be entered into a free competition as set out on Twitter (the “**Competition**”) to win a 1 (one) night stay on a weekend period until April 30th 2018 at the onsite Novotel Hotel (double bed & breakfast) with 1 (one) green-fee/person to play the 2018 Ryder Cup course.
2. This competition is not open to employees of Le Golf National or PGA European Tour (“**European Tour**”) or their group companies, their families, agents or anyone else connected with this promotion. European Tour reserves the right to verify the eligibility of entrants. By entering the Competition, you are deemed to have read and accepted these Terms and Conditions.
3. By entering the Competition, you are deemed to have read and accepted these Terms and Conditions.
4. Entries must be made by ‘retweeting’ the Tweet and ‘following’ the PGA European Tour Properties Twitter page. Entries received after the stipulated closing time and date will be invalid and will not be included in the Competition.
5. Entrants must be UK residents and over 18 years of age and may be required to provide proof of identity. Only one entry per person. No third-party entries, bulk entries or entries submitted by agents will be accepted.
6. Any instructions provided in the Tweet form part of the Terms and Conditions of the Competition, but in the event of a conflict, these Terms and Conditions take precedence. Entries not complying with these Terms and Conditions will be invalid.
7. European Tour accepts no responsibility for entries that are not successfully completed due to a technical fault (including without limitation technical malfunction, computer hardware or software failure, satellite, network or server failure) of any kind.
8. The Prize shall be the tickets, product, experience, or otherwise as is more particularly stipulated in these Terms and Conditions.

10. The closing date for entries is 23:59pm on [28/03/2018] (the “**Closing Date**”). The winner will be selected at random by a draw from all eligible entries conducted by European Tour. An independent observer shall supervise the draw. The draw shall take place on [29/03/2018]. All eligible entries made in accordance with these Terms and Conditions and any additional instructions in the Tweet shall be included in the draw.
11. The Prize does not include flights, personal items, transfers, transport or any activities not mentioned in clause 1 above. The winner shall be responsible for all necessary permits,

identification, travel arrangements and insurances, including without limitation travel insurance. The Prize shall be valid until 30 April 2018 and use of the Prize is excluded during competitions, special events and in accordance with golf course access conditions and room availability at the onsite Novotel.
